#### REPAYMENT TERMS

The day camp registration fee will be refunded in full less an administration fee of 10% in the case of a cancellation more than one month before the start of the day camp. Fees will not be refunded in the event of a cancellation less than a week before the start of the day camp, or for missed camp days.

If the child can no longer participate in day camp activities for health reasons (medical evidence), the Town of Bedford will reimburse the full registration fee less the cancellation fee of \$ 25.
